# Why Curious Minds needs this role

**Curious Minds** delivers a wide range of training, support and events aimed at improving the lives of children and young people through access to quality arts and cultural experiences and opportunities. We do this predominantly by working with the people from across the cultural education sector (teachers, educators, creative freelancers, cultural organisations, and the youth sector). We need to be able to be flexible and responsive to additional demand whilst ensuring we maintain our reputation for high quality training and events.

Associates work on several our programmes as part of our extended workforce. These programmes include Artsmark, Leading the Arts in Your School, curiosity-led evaluation, and project management - this list is indicative, but not exhaustive. This work is not about delivering practical art form skills.

We are looking for a group of individuals with skills and knowledge in one or more of the following: education, arts, culture, and heritage who are interested and able to work with us.

In order to ensure quality and consistency we will provide a paid induction; one day face-to-face and two half-day online sessions, providing background on our programmes, values, and approaches. Additional paid training may be provided if you are invited to work on specific programmes.

Membership of this pool does not guarantee work although if we need support, you will be our "go to" people.

We will pay £500 plus travel (public transport or a mileage rate/parking) to those we invite to the induction.

If you are accepted as an associate, you must be willing to undergo an enhanced DBS check and provide us with a current public liability insurance certificate.
